## Section 3 – External Auditor Report and Certificate 2019/20

## 1 Respective responsibilities of the body and the auditor

This authority is responsible for ensuring that its financial management is adequate and effective and that it has a sound system of internal control. The authority prepares an Annual Governance and Accountability Return in accordance with *Proper Practices* which:

- summarises the accounting records for the year ended 31 March 2020; and
- confirms and provides assurance on those matters that are relevant to our duties and responsibilities as external auditors.

Our responsibility is to review Sections 1 and 2 of the Annual Governance and Accountability Return in accordance with guidance issued by the National Audit Office (NAO) on behalf of the Comptroller and Auditor General (see note below). Our work **does not** constitute an audit carried out in accordance with International Standards on Auditing (UK & Ireland) and **does not** provide the same level of assurance that such an audit would do.

## 2 External auditor report 2019/20

Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

- Section 1, Assertion 4 has been incorrectly completed. The Internal Auditor has confirmed that the smaller authority did not provide the proper opportunity for the exercise of public rights in summer 2019, as the date of announcement was not at least one day prior to commencement of the period allowed for inspection. The response to Assertion 4 should have therefore been 'No'.
- Section 1, Assertion 5 has been incorrectly completed. The Internal Auditor has confirmed that the smaller authority did not carry out an annual risk assessment.

The AGAR was not fully completed before submission for review. Section 1, Box 6 of the AGAR have not been completed.

Other matters not affecting our opinion which we draw to the attention of the authority:

In the completion of the Annual Internal Audit Report, and their detailed report, the internal auditor has drawn attention to significant weaknesses in relation to the lack of risk assessment and provision of the proper opportunity for the exercise of public rights. This is consistent with the Except for Matters raised above. The smaller authority must ensure that action is taken to address these areas of weakness in a timely manner.
