56/25	<ul> <li>Chairman's Report:- Chairman's Report circulated as follows for 2023/2024:-</li> <li>I am unashamed in repeating my thanks again this year for all the volunteers, especially Parish Councillors, who help make the administration of the parish run smoothly.</li> <li>Sadly, we have said goodbye to Tony Barnaby who has served on the Parish Council as Councillor for many years. In particular Tony has provided practical support to the Parish and the Council. When repairs were needed, he has been first in line to help. When going through an extended period without a permanent cleaner for the public toilets in Lanivet Tony and his wife, Elaine, stepped into the breach for over 3 months without asking for a penny for their services. Not only did it mean the savings could be used elsewhere but it highlights the high calibre Councillors the parish has, who should not be taken for granted. Unfortunately, there are no formal mechanisms to recognise his long-term contribution to the Parish.</li> </ul>		

- Even though Tony has retired from the Parish Council I have no doubt that he will personally support the community in his own way. Thankfully the vacancy has been filled by Colin Woolley from Lanivet.
- I also want to take the opportunity to thank our Ward Member Jenny Cruse who has continued to be so supportive to the parish over the past year.
- The Affordable Housing Project has sadly run its course now that the landowner has taken back ownership for the land. After many delays for various reasons outside of our control plus a large increase in the cost of building the homes, we are unable to progress this project. We wait to see whether any homes will be built there.
- Further congratulations are in order for the Nanstallon Community Trust.
  Having secured the premises last year, they have now completed extensive
  renovation of the old Methodist Church to make it fit for purpose as a modern
  community venue. I am pleased to report that the parish council was able to
  purchase kitchen equipment for the Nanstallon Village Hall. We were also
  pleased to hear that the organ has been donated to an organisation in St.
  Austell
- Again, many congratulations to Jessica Finnemore and her team for the progress on building a new Under 5's facility near the Lanivet Community Centre. I am pleased that the Parish Council has made funds available to help with this project.
- I am reminded so often of the preciousness of village life that cannot be replicated in any other setting. We are truly blessed with some remarkable people who give their time and themselves selflessly for the benefit of the whole community. To them I again say Thank You.

**Annual Report from Cornwall Councillor:-** Report received from Cornwall Councillor Mrs. J. Cruse as follows:-

- It seems incredible that this is my fourth year as your Cornwall Councillor. The
  number of emails and cases has increased over this period of time, with more
  and more complex cases coming forward. The reduction in Councillors has
  increased our work load by 30% and is now a very time-consuming position. I
  have used the Casework Assist feature and found it generally effective to get
  to the right officer within the Council to deal with the matter.
- Committee work continues to take a great deal of time, since each meeting requires the reading of hundreds of pages, and all to be diligently read since we are taking important decisions on many matters, particularly in planning and health care.
- I have taken this very seriously with a 92% attendance across all committees and Full Council. I have personally not been involved in finances or constitutional matters since I do not feel I have great expertise in that domain. Financially the Council has struggled partly to do with the payment of some rather nasty debts incurred by the previous administration which were due to impart a 53 million surcharge if not paid off and the increase in demand for Adult Social Care and Children's services as well as the increase in temporary housing requirements. The Portfolio holder for Finance and the Financial Officers have produced a balanced budget and they are to be congratulated particularly since the Labour Government has reduced funding and cut the Rural grant. I would add it was a piece of cross-party co-operation which enabled the Budget to be approved, and I feel this is particularly noteworthy.

	<ul> <li>I enjoy my role on the Harbours Board and would like to mention how well this is run by the Maritime Manager Chris Jones, his grasp of all matters to do with the Harbours is excellent and our reserves have increased annually with some great improvements to some harbours. I have also found my role on the National Landscape Partnership very enjoyable and there have been some excellent public participation events where we have been able to involve residents who may not normally access these wonderful spaces.</li> <li>I have also been pleased to note that more members of the public have used the 'report it' system which has enabled a more accurate recording of where problems are positioned, and I have always found it to be a very effective system.</li> <li>There is much to be said for continuity, and it is my hope that our administration is able to continue looking after Cornwall in the following four years.</li> <li>Chair thanked Cornwall Councillor Mrs. J. They have provided heating grants for 66 people within the parish, donated towards the replacement windows at the methodist church and has financially supported the construction of the purpose build preschool within the village.	
62/25	<ul> <li>Nanstallon Cemetery Annual Report:- Clerk circulated report from Tamsin Stickland for the period pf April 2024 to April 2025 as follows:-</li> <li>At my last report Reg Sheppard had stepped down as secretary and Trustee to the cemetery and this had been handed over to Tamsin Stickland. We are sad to report Reg passed away last June and our thoughts have been with his family. Reg has been buried in the cemetery. We hope to arrange for a memorial bench for Reg.</li> <li>This last year and to date saw a higher number of burials and cremated remains.</li> <li>Mr. Fred Butler has continued mowing the new part of the cemetery and George Kestell selectively strimming the old part encouraging a massive range of flora and fauna. In the old part some of the trees requires the removal of dead branches and grass paths for ease of mowing.</li> <li>Remembrance Sunday again, was well attended and this year we had 2 locals attend on horseback to represent the animals who lost their lives. This added a lovely extra sentiment.</li> <li>Finances are in a healthy state.</li> <li>From my last report I had been looking into getting a Commonwealth War Graves recognition for the war hero Alfred Perryman buried in the cemetery.</li> </ul>
